

## तीन वर्षमा...

आव ०७२/७३ मा सेयर बजार पुँजीकरण १८ खर्ब ९० अर्ब रहेकोमा गत असार मसान्तमा यो १७ प्रतिशतले घटेर १५ खर्ब ६७ अर्ब छ। आव ०७२/७३ अघि जिडिपीसँग बजार पुँजीकरणको अनुपात ४६ प्रतिशत रहेकोमा सो वर्ष ८३.८८ प्रतिशतसम्म पुगेको थियो। अहिले भने यस्तो अनुपात ४५ प्रतिशत छ। लगातीकर्ताको ३ खर्ब २३ अर्बले रुपैयाँ नै नोक्सान भएको भने होइन। यसलाई कागजी मूल्यांकनमा भएको क्षय भनिन्छ। किनभने लगातीकर्ताले किनेको अवधिको मूल्य र ब्रेचेको अवधिको मूल्यमा हुने नाफा-

घाटा मात्रै वास्तविक हुन्छ। यद्यपि, दुई वर्षदेखि बजार १२ सयकै तहआसपास रहँदा लगातीकर्ताहरूलाई केही हदसम्म घाटा पनि भएको छ।

हाल सरकारले लगातीकर्ताको मनोबल बढाउन नसकेको र नीतिगत भ्रमेलाहरू ल्याएकाले पनि बजार बढ्न सकेको छैन। 'अहिले पनि सेयरमा लाग्ने पुँजीगत लाभकरमा समस्या छ, यसले पनि लगातीकर्ताहरूलाई थप लगाती गर्न हतोत्साही बनाएको छ,' भइराईले भने। उनले नियम लागू भएको दिनलाई नै आधार मानेर लाभकर लगाउनुपर्नेमा सरकारले नीति आउनुअघिदेखिको कारोबारमा समेत कर लाग्ने व्यवस्था गरेको कारण बजारमा समस्या आएको बताए।

पहिले डिम्याट भएर पनि कारोबार नभएका वा हालै कागजी सेयर डिम्याट भइरहेका सेयरको मूल्य हालको कारोबार प्रणालीबाट देखिँदैन। यही कारण लगातीकर्तालाई खरिद मूल्य निकाल्न असहज भएको छ। लगातीकर्ताले या त प्रणालीले तोकेको मूल्य एक झ्रय रुपैयाँलाई नै खरिद मूल्य मान्नु या आफूले नै सम्भरेर मूल्य तोक्नुपर्ने अवस्था छ। एक सय रुपैयाँ मूल्य मान्दा बढी कर तिर्नुपर्नेसमेत पर्ने भएकाले लगातीकर्ता त्यसमा इच्छुक देखिँदैनन्। लगातीकर्ता आफैले तोकेको मूल्यमा आन्तरिक राजस्व विभागले कुनै कारणवश अनुसन्धान गर्दा नमिलेमा र कर लाग्ने भए पनि नबुझाएको देखिएमा कारबाहीमा पुर्नुपर्ने अवस्था छ।

Bidding is open to all eligible as per Section V of bidding document
- Junichaande Rural Municipality** invites sealed bids and electronic bids from eligible bidders for the **Construction of Junichaande Rural Municipality 4 No. Ward Office Building** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:
  - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 2, 00, 00,000. Without VAT.**
  - Minimum Work experience of similar size and nature: **1 no. and value of project NRs 2, 20, 00,000. Without VAT.**
- Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

- Interested Bidders shall submit the electronic bids through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12pm on 4 november 2019**. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at **2pm on 4 november 2019** at the office of Junichaande Rural Municipality Majkot, Jajarkot, Karnali Province, Nepal. Bids must be valid for a period of **120 Days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 7,50,000.**, which shall be valid for 30 days beyond the validity period of the bid
- If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
