Invitation for Electronic Bids for the Lamatara-Budi Road

The Junichaande Rural Municipality has allocated funds and received a grant from GoKP towards the cost of Lamatara-Budi Road and intends to apply part of the funds to cover eligible payments under the Contract for Lamatara-Budi Road, identification number JCRM/NCB/G/WORKS/11/076/077. Bidding is open to all eligible as per Section V of bidding document.

Junichaande Rural Municipality invites electronic bids from eligible bidders for the Lamatara-Budi Road under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:

Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs 3, 08, 00,000.
 Without VAT.

Minimum Work experience of similar size and nature: I no. and value of project NRs 3, 28, 00,000. Without VAT.
 At least 2,15,000.00 cum cutting of soil (all types of soil, BMS soil, soft rock or hard rock) in Hilly or Mountain Region

3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

6. Interested Bidders shall submit the electronic through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12pm on 4 February 2020. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 2pm on 4 February 2020 at the office of Junichaande Rural Municipality Majkot, Jajarkot, Karnali Province, Nepal. Bids must be valid for a period of 120 Days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 5,08,000., which shall be valid for 30 days beyond the validity period of the bid.

8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
